About our judge



Frank Hedtke (ADRK)

Frank Hedtke has been a member of the ADRK since 1972. He is Chairman and Breed Warden of the BG Dortmund-Bövinghausen e.V. and has also been a IPO competition helper at a total eight ADRK Korungs. Frank is the current owner of von Sofienbusch Rottweilers, one of the oldest still active kennels within the ADRK which his late father, Willi Hedtke, took over from Theodor Busch in 1960.

Historians in the breed will be interested to know that von Sofienbusch kennels is the birthplace of one of the most famous Rottweilers ever, the triple Bundessieger, Harras vom Sofienbusch who was born 13.12.1957. Harras proved an influential stud in Germany and was exported to the USA at six years old where he was instrumental in the development of the Rottweiler in that country. Frank's involvement in the Rottweiler is a real family affair as his father became an ADRK Breed Judge in 1966 and was long serving Chairman of the BG Dortmund-Bövinghausen e.V. Willi Hedtke was also the Chief Breed Ward for the ADRK from 1981-1996.

Meridian Rottweiler League is excited to have secured Frank's services as the Breed Judge for our 2012 championship show and have no doubt that exhibitors and local supporters of the Rottweiler will learn a great deal from his expertise and knowledge.
